Consider characteristics and needs of special populations.

#### Option 2: Crucial Digital Follow Up and Recovery in Missing and Runaway Cases

Wayne Nichols, Associate, National Criminal Justice Training Center of Fox Valley Technical College | Review how to properly save communications in your investigation, and how to determine what apps are involved in your cases. Consider important elements of cell phone and tablet 'usage.' Learn about extensions that support proper case documentation. Follow case studies which illustrate adding 'account takeover' language to your search warrants.

#### Option 3: Long-Term Missing and Unresolved Abduction Homicides

**Brian Killacky, Associate, National Criminal Justice Training Center of Fox Valley Technical College** | Learn the importance of evidence preservation and chain of custody in property originally inventoried to effectively support direct and indirect evidence. Consider the importance of continued family advocacy in effectively supporting them as leads are developed and as complex issues arise. Explore current forensic capabilities and investigative strategies in historical cases.

### Option 4: Developing an AMBER Alert Plan for Tribal Communities

Tyesha Wood, Project Coordinator, National Criminal Justice Training Center of Fox Valley Technical College | Examine past child abduction and exploitation events on tribal lands and the challenges facing tribes in protecting children. Review the Ashlynne Mike AMBER Alert in Indian Country Act of 2018. Develop strategies for implementing an AMBER Alert plan within tribal communities. Discover current resources available through the AMBER Alert Training and Technical Assistance Program.

### Option 1: Child Abductions – Current Trends in Technology

Explore digital tools needed to support your investigation. Review initial steps to take with parents or guardians regarding social media platforms. Consider differences in data from cell phone towers versus GPS platforms.

#### Option 2: Search and Canvass in Missing and Abducted Children Cases

Derek Van Luchene, CART Program Coordinator, National Criminal Justice Training Center of Fox Valley Technical College | Examine the statistics involved in searches for missing and abducted children. Review important resources and best practices in search and canvass operations. Analyze recent missing and abducted child cases where search and canvass operations were key in recovering the child.

#### Option 3: Legal Issues in Missing and Abducted Child Investigations

Judge Mark McGinnis, Associate, National Criminal Justice Training Center of Fox Valley Technical College | Compare and analyze, from a legal perspective, situations faced by law enforcement during the search for and/or recovery of a missing child. Discuss alternative techniques and legal theories which may help law enforcement search for a child without applying for a warrant – even when a warrant could not have been obtained.

#### Option 4: Technological and Specific Resources Needed to Support Tribal AMBER Alert Plans

Harland Cleveland, Associate, National Criminal Justice Training Center of Fox Valley Technical College | Consider areas most critical to tribal agencies in terms of accessing and using technology to support AMBER Alert plans and operations in Indian Country. Examine and discuss effective technologies and their use, and how best to involve the entire community in the search for a missing child.
