Number of cases of technology-facilitated crimes against children referred to a prosecutor for charging</p> <p><b>(Program Specific)</b></p>	<p>A prosecutor is a trial lawyer representing the government and the interests of the state, who is responsible for deciding who and when to prosecute a case. Charging is when a prosecutor formally accuses an individual of breaking a law.</p>	<p>A.
