### Overview

The [U.S. Department of Justice](#) (DOJ), [Office of Justice Programs](#) (OJP), [Office of Juvenile Justice and Delinquency Prevention](#) (OJJDP) seeks applications for funding for fiscal year (FY) 2022 Victims of Child Abuse Act Programs. This program furthers the DOJ's mission by providing funding for a national training and technical assistance program to enhance the effectiveness of attorneys who investigate and prosecute child abuse cases. The primary objective of this program is to train entry-level, mid-career, and seasoned prosecutors.

This solicitation incorporates the [OJP Grant Application Resource Guide](#) by reference. The OJP Grant Application Resource Guide provides guidance to applicants on how to prepare and submit applications for funding to OJP. **If this solicitation expressly modifies any provision in the OJP Grant Application Resource Guide, the applicant is to follow the guidelines in this solicitation as to that provision.**

### Other

Eligibility is limited to national organizations that have a broad representation of attorneys who prosecute criminal cases in state courts and have demonstrated experience in providing training and technical assistance for prosecutors. For purposes of this solicitation, whether an organization has a broad representation of attorneys will be determined based on those attorneys who are currently employees of the applicant organization, paid consultants, and/or attorneys from the applicant's partner/subrecipient agencies. Nonprofit organizations that hold money in offshore accounts for the purpose of avoiding paying the tax described in 26 U.S.C. § 511(a) are not eligible to apply.

To advance Executive Order 13929 Safe Policing for Safe Communities, the Attorney General determined that all state, local, and university or college law enforcement agencies must be certified by an approved independent credentialing body or have started the certification process, to be eligible for FY 2022 DOJ discretionary grant funding. To become certified, the law enforcement agency must meet two mandatory conditions: (1) the agency's use-of-force policies adhere to all applicable federal, state, and local laws and (2) the agency's use-of-force policies prohibit chokeholds except in situations where use of deadly force is allowed by law. The certification requirement also applies to law enforcement agencies receiving DOJ discretionary grant funding through a

## Submission Information

Applications will be submitted to DOJ in two steps:

**Step 1:** The applicant must submit by the Grants.gov deadline the required Application for Federal Assistance standard form (SF)-424 and a Disclosure of Lobbying Activities (SF-LLL) form when they register in Grants.gov at <https://www.grants.gov/web/grants/register.html>.

Beginning April 4, 2022, the Federal government will cease using the Data Universal Numbering System (DUNS) number to uniquely identify entities. At that point, entities doing business with the Federal government will use a Unique Entity Identifier (UEI) created in SAM.gov. If your entity is currently registered in SAM.gov, your UEI has already been assigned and is viewable in SAM.gov. This includes inactive registrations. If you are a new entity registering in SAM.gov, you will continue to register in SAM.gov using the DUNS number assigned by Dun and Bradstreet (D&B) until April 4, 2022. 2) Wait until April 1, 2022, to begin and submit the Grants.gov application.

## **Program Description**

### **Overview**

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community. The OJJDP FY 2022 Victims of Child Abuse (VOCA) Act Training and Technical Assistance for Child Abuse Prosecutors program will fund a national training and technical assistance program for attorneys who are involved in the criminal prosecution of child abuse to enhance the effectiveness of the investigation and prosecution of such crimes.

### **Statutory Authority**

34 U.S.C. Section 20305

### **Specific Information**

The successful applicant will operate a national training and technical assistance program for attorneys who are instrumental to the criminal prosecution of child abuse cases for the purpose of improving the quality of criminal prosecution of such cases.

The training and technical assistance program will address a wide range of topics related to improving the investigation and prosecution of child abuse and neglect, including information regarding improved child interview techniques, thorough investigative methods, interagency coordination, and effective presentation of evidence in court. Training and technical assistance will be provided to prosecutors who prosecute child abuse cases in juvenile and adult courts. The training and technical assistance program will address the prosecution of child physical abuse, child sexual abuse, technology-facilitated child exploitation, and child fatalities. It will also address more specialized topics, such as serial child torture, abusive head trauma, prosecution of abusive burn cases, drowned child cases, hot car deaths, and investigation of female offenders.

The OJJDP VOCA-funded programs have expanded to develop and enhance the capacity of children's advocacy centers (CAC) to serve child victims of pornography and sex trafficking through providing targeted subgrants and training and technical assistance in this area. In addition, OJJDP is aware of the nexus between the expertise of the Internet Crimes Against Children (ICAC) task forces and the multidisciplinary teams operated by CACs across the country. Many ICAC task forces and CACs have memoranda of understanding to support training and coordinated responses to victims of child exploitation and sex trafficking. OJJDP expects this training and technical assistance program to also address issues related to the handling of cases that involve the exploitation of children and youth, and the successful applicant will participate in joint training with the OJJDP-funded ICAC training and technical assistance providers as directed by OJJDP.

### **Goals, Objectives, Deliverables, and Timeline**

#### **Goals**

The program's goal is to improve the quality of criminal prosecution of child abuse cases

#### **Objectives**

To achieve its goal, OJJDP has established the following objectives:

1. Develop and provide training opportunities for local and state prosecutors involved in child abuse cases for the purpose of improving the quality of criminal prosecution of such cases.
2. Deliver technical assistance efforts for local and state prosecutors involved in child abuse cases for the purpose of improving the quality of criminal prosecution of such cases.
3. Develop and promote publications and resources for local and state prosecutors involved in child abuse cases for the purpose of improving the quality of criminal prosecution of such cases.
4. Coordinate proposed training and technical assistance with other OJJDP-funded VOCA programs to maximize efficient use of resources and avoid duplication of efforts.

#### **Deliverables**

As a part of their program design, the successful applicant will develop plans for achieving the above objectives by designing and implementing the following activities:

Design and provide training sessions (onsite, cross-site, telephone, web-based, etc.) for prosecutors at the local, state, regional, and national levels. The applicant will propose the topics, types, quantity, duration, audiences,

timing, and means of delivery of training sessions; identifying trainers with relevant expertise and audiences with significant need. The applicant will include plans for evaluating training sessions to include measuring changes in participants' knowledge, attitude, and behavior. Applicants should detail their planned training portfolio, which will be approved by OJJDP prior to delivery

2. Deliver in-person and remote technical assistance for prosecutors that is designed to enhance the investigation and prosecution of child abuse. Applicants should detail their planned approach for technical assistance.
3. Deliver in-person and remote technical assistance for prosecutors that is designed to enhance the investigation and prosecution of child abuse. Applicants should detail their planned approach for technical assistance.
4. Create publications and resources to enhance the investigation and prosecution of child abuse. The applicant will indicate the topics, types, quantity, audiences, and production schedule for proposed publications, identifying the authors and contributors. The applicant will create a plan to disseminate publications and measure their impact and, at a minimum, will collect data on the number disseminated, the number of times online versions are accessed, and the types of users. The plan for proposed publications must receive prior approval from OJJDP.
5. Develop methods to solicit customer feedback and to update training and technical assistance efforts based on feedback received.

OJJDP will assign major tasks and deliverables under this solicitation that are based on a review of the successful application. OJJDP will expect the successful applicant to coordinate any training and technical assistance activities with all other OJJDP-funded VOCA grantees, as OJJDP directs. OJJDP will have final approval of all proposed training sessions funded through this grant program.

The Goals, Objectives, and Deliverables are directly related to the performance measures that show the completed work's results, as discussed under Application and Submission Information.

#### **OJJDP Training and Technical Assistance Awardee Standards**

OJJDP has developed the Core Performance Standards for Training, Technical Assistance, and Evaluation to promote among providers the consistency and quality of OJJDP-sponsored training and technical assistance and to advance common expectations of performance excellence. The standards present minimum expectations that providers must meet for effective practice in the planning, coordination, delivery, and evaluation of training.

Requirements related to coordination of activities will include, but are not limited to:

- **Coordination with OJJDP NTTAC.** OJJDP requires all training and technical assistance projects to coordinate their activities with the OJJDP National Training and Technical Assistance Center (NTTAC) by complying with all OJJDP/NTTAC protocols to ensure coordinated delivery of services among providers and the effective use of OJJDP grant funding. OJJDP reserves the right to modify these protocols at any time with reasonable notice to the grantee prior to project completion.
- **OJJDP-funded webinars.** The award recipient must comply with OJJDP's webinar guidelines, as described in the Core Performance Standards. Minimally, OJJDP training and technical assistance providers will submit information to OJJDP in advance of all events for the online calendar, record events, and provide the final files (which must be compliant with Section 508 of the Workforce Rehabilitation Act) to OJJDP or OJJDP's representative. To receive this additional priority consideration, applicants must describe how being a culturally specific organization (or funding the culturally specific subrecipient organization(s)) will enhance their ability to implement the proposed project(s) and should also specify which culturally specific populations are intended or expected to be served or to have their needs addressed under the proposed project(s).

Culturally specific organizations are defined for purposes of this solicitation as private nonprofit or tribal organizations whose primary purpose as a whole is to provide culturally specific services to, among others, Black people, Hispanics and Latino/a/e people, Native American and other Indigenous peoples of North America (including Alaska Natives, Eskimos, and Aleuts), Asian Americans, Native Hawaiians, and/or Pacific Islanders.

#### **Proposal Abstract**

A proposal abstract (no more than 400 words) summarizing the proposed project, including the purpose of the project, primary activities, expected outcomes, the service area, intended beneficiaries, and subrecipients (if known), will be completed in the JustGrants web-based form. This abstract should be written in the third person and will be made publicly available on the OJP website if the project is awarded.

#### **Proposal Narrative**

The proposal narrative should be submitted as an attachment in JustGrants. The attached document should be double-spaced, using a standard 12-point font; have no less than 1-inch margins; and should not exceed 30 pages. Pages should be numbered and submitted as an attachment. If the proposal narrative fails to comply with these length restrictions, OJJDP may consider such noncompliance in peer review and in final award decision.

The following sections must be included as part of the proposal narrative:

##### a. Description of the Issue

Applicants should briefly describe the nature and scope of the problem that the program will address. The applicant should use data to provide evidence that there is a need for training and technical assistance resources for child abuse prosecutors, demonstrate the size and scope of the problem, and document the effects of the problem on the target population and the larger community. Any data or research referenced in the narrative should include information about the source of the data and/or a citation. Applicants should describe the target population and any previous or current attempts to address the problem. Applicants should describe any research or evaluation studies that relate to the problem and contribute to their understanding of its causes and potential solutions. While OJJDP expects applicants to review the research literature for relevant studies, they should also explore whether unpublished local sources of research or

evaluation data are available.

b. Project Design and Implementation

Applicants should detail how the project will operate throughout the funding period and describe the strategies that they will use to achieve the goals and objectives identified in the previous section. Applicants should describe how they will complete the deliverables stated in the Goals, Objectives, and Deliverables section. 5. Budget (10%) – evaluate for completeness, cost effectiveness, and allowability (e.g., reasonable, allocable, and necessary for project activities).

### **Review Process**
