# Overview

The U.S. Department of Justice (DOJ), Office of Justice Programs (OJP), Office of Juvenile Justice and Delinquency Prevention (OJJDP) seeks applications for funding for the fiscal year (FY) 2022 Victims of Child Abuse Regional Children's Advocacy Centers program. This program furthers the DOJ's mission by supporting and strengthening four regional children's advocacy centers that will deliver coordinated training and technical assistance within and across the regions to members of multidisciplinary teams, programs, and organizations to improve the investigation and prosecution of child abuse and neglect and the provision of children's advocacy center services to child victims and their families.

Eligible applicants are limited to local public and private nonprofit children's advocacy center agencies and organizations that can demonstrate a minimum of 5 years of experience providing regional or national training and technical assistance to a wide range of multidisciplinary professionals and others (including children's advocacy center staff) with respect to the judicial handling and investigative response to child abuse and neglect cases.

Nonprofit organizations that hold money in offshore accounts for the purposes of avoiding paying the tax described in 26 U.S.C. 511(a) are not eligible to apply.

To advance Executive Order 13929 Safe Policing for Safe Communities, the Attorney General determined that all state, local, and university or college law enforcement agencies must be certified by an approved independent credentialing body or have started the certification process, to be eligible for FY 2022 DOJ discretionary grant funding. To become certified, the law enforcement agency must meet two mandatory conditions: (1) the agency's

# **Program Description**

#### Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

The OJJDP FY 2022 Victims of Child Abuse (VOCA) Regional Children's Advocacy Centers (RCAC) program supports four regional centers—one situated within each of four designated U.S. Census regions—that enhance and support the development, expansion, and continuous quality improvement of multidisciplinary teams, local children's advocacy centers (CACs), and state chapter organizations responding to child abuse and neglect cases to improve the investigation and prosecution of child abuse and neglect and the provision of children's advocacy center services to child victims and their families.

#### **Statutory Authority**

Victims of Child Abuse Act, 34 U.S.C. 20303

#### **Specific Information**

The Victims of Child Abuse Act (VOCAA) provides for the establishment of regional CACs to deliver coordinated information, resource development, technical assistance, and training to assist communities in establishing facility-based multidisciplinary programs that respond to child abuse and neglect. The RCAC program's purpose is to improve the nation's response to child abuse and neglect through strategic coordinated delivery of training and technical assistance (TTA) to multidisciplinary teams, local CACs, and state chapter organizations. Additionally, under the RCAC program, each RCAC will work collaboratively and strategically with all other VOCAA TTA partners to provide strategic leadership, resource maximization, and capacity building nationwide.

CACs provide a coordinated response to victims of child abuse through multidisciplinary teams composed of representatives from community agencies and professionals involved with intervention, prevention, prosecution, and investigation systems that respond to child abuse and neglect cases. The program objectives of a CAC are to:

- Assist communities in developing child-focused, community-oriented, facility-based programs to improve the resources available to child victims and families.
- Provide support for family members who are not engaged in child abuse and neglect.
- Enhance coordination among community agencies and professionals involved in the intervention, prevention, prosecution, and investigation systems that respond to child abuse and neglect cases.
- Train physicians and other healthcare and mental healthcare professionals in the multidisciplinary approach to child abuse and neglect.

Successful operation of the RCAC program requires significant coordination and collaboration. To achieve the necessary level of coordination, OJJDP will require each of the four successful applicants to work in close partnership with each other and with all programs funded under the VOCAA. These programs include:

- Children's Advocacy Centers Membership and Accreditation Program.
- Training and Technical Assistance for Child Abuse Prosecutors.
- Training and Technical Assistance for Child Abuse Professionals.
- Children's Advocacy Centers National Subgrant Program.
- Tribal Children's Advocacy Centers Training and Technical Assistance Program.

OJJDP expects each regional awardee to strategically collaborate with all of the VOCAA-funded programs to annually maintain and update a 5-year strategic plan and a related operational plan to align efforts, maximize resources, and outline clear roles and responsibilities across the partners.

### Goals, Objectives, Deliverables, and Timeline

The goal of this solicitation is to fund four regional children's advocacy centers – one in each of the four U.S. Census regions – that will provide coordinated delivery of a full complement of training, technical assistance, resource development, and information to develop and strengthen multidisciplinary team investigations and responses to child abuse and neglect.

The states included in each of the four U.S. Census Regions are:

- Northeast Region: Connecticut, Maine, Massachusetts, New Hampshire, New Jersey, New York, Pennsylvania, Rhode Island, and Vermont.
- Southern Region: Alabama, Arkansas, Delaware, District of Columbia, Florida, Georgia, Kentucky, Louisiana, Maryland, Mississippi, North Carolina, Oklahoma, South Carolina, Tennessee, Texas, Virginia, and West Virginia.
- Midwest Region: Illinois, Indiana, Iowa, Kansas, Michigan, Minnesota, Missouri, Nebraska, North Dakota, Ohio, South Dakota, and Wisconsin.
- Western Region: Alaska, Arizona, California, Colorado, Hawaii, Idaho, Montana, Nevada, New Mexico, Oregon, Utah, Washington, and Wyoming.

# Objectives

To accomplish its goal, OJJDP has outlined the following objectives to be achieved:

- Deliver systematic, coordinated, customized TTA in partnership with the other regions to communities, CACs, and state chapters that expand and strengthen capacity for a comprehensive, multidisciplinary approach to the investigation and prosecution of child abuse and neglect cases and evidence-based treatment for child abuse and neglect victims.
- Develop and strengthen capacity of state chapter organizations to deliver TTA to local CACs to meet the needs within the state on their own.
- Develop and/or expand TTA curricula, publications, and resources to support optimal practice implementation and to address new, emerging, and innovative areas identified as needed in the field.

# Deliverables

The following lists the required deliverables for each RCAC, such as expected products, services, or activities that should be developed/delivered as a result of this program:

- Develop a joint plan to implement a systematic, coordinated TTA approach for CACs, multidisciplinary teams (MDTs), and state chapter organizations. The joint plan shall involve all four RCACs and the Tribal CAC TTA provider. The plan will be submitted to OJJDP for review and approval within 6 months of award.
- Conduct annual statewide TTA assessments in partnership with each state chapter within the region to develop a statewide TTA plan to address the needs of each state's local CACs and MDTs. These assessments will include state chapter capacity assessment and identification of any state chapter TTA needs.
- Develop and implement a coordinated TTA delivery plan annually for the region that is informed by the needs/priorities identified through the statewide TTA assessments and coordinated with other RCACs.
- Provide high-quality, customized technical assistance based upon needs identified in the above assessments and delivered in a systematic, coordinated process adopted across the RCACs.

- Deliver high-quality training opportunities for CACs, MDTs, and state chapters, including delivery of trainthe-trainer approaches to increase impact, capacity, and reach based upon the above assessments.
- Develop and deliver resources, publications, and curricula to support the specific emerging needs of CACs and state chapters, including train-the-trainer materials based upon collaborative strategic alignment with VOCAA national partners.
- Strategically collaborate with the VOCAA-funded program partners to produce and annually maintain and update a 5-year strategic plan and a related operational plan to align efforts, maximize resources, and outline clear roles and responsibilities across the partners. Plans need to be delivered to OJJDP for review and approval by the tenth month of each year of the project following award. Each RCAC will be expected to participate in regularly scheduled VOCAA program partner meetings with OJJDP.

The Goals, Objectives, and Deliverables are directly related to the performance measures that show the completed work's results, as discussed in the Application and Submission Information section.

# **OJJDP Training and Technical Assistance Awardee Standards**

OJJDP has developed the Core Performance Standards for Training, Technical Assistance, and Evaluation to promote among providers the consistency and quality of OJJDP-sponsored training and technical assistance and to advance common expectations of performance excellence. The standards present minimum expectations that providers must meet for effective practice in the planning, coordination, delivery, and evaluation of training.

# **Proposal Abstract**

A proposal abstract (no more than 400 words) summarizing the proposed project, including the purpose of the project, primary activities, expected outcomes, the service area, intended beneficiaries and subrecipients (if known), will be completed in the JustGrants web-based form. This abstract should be written in the third person and will be made publicly available on the OJP website if the project is awarded.

# **Proposal Narrative**

The proposal narrative should be submitted as an attachment in JustGrants. The attached document should be double-spaced, using a standard 12-point font; have no less than 1-inch margins; and should not exceed 30 pages. Pages should be numbered and submitted as an attachment. If the proposal narrative fails to comply with these length restrictions, OJJDP may consider such noncompliance in peer review and in final award decision.

The following sections must be included as part of the proposal narrative:

a. Description of the Issue

Applicants should briefly describe the nature and scope of the issue that the program will address (e.g., define and describe the TTA needs of MDTs, CACs, and state chapter organizations across the applicable region) and demonstrate the size and scope of the problem (i.e., TTA needs). The applicant should use data to provide evidence that the problem exists, such as identifying methods and results of training needs assessments, gaps in capacity across the field, TTA gaps, and assessment of gaps in the both the quality and the reach of CACs and MDTs, and analysis of state chapter capacity needs in the applicable region.

Any data or research referenced in the narrative should include information about the source of the data and/or a citation. Applicants should also provide information on how they have identified the needs in their respective regions and describe their strategic planning process for meeting those needs.

Applicants should describe any research or evaluation studies that relate to the problem (i.e., regional TTA needs of the children's advocacy field) and contribute to their understanding of its causes and potential solutions. While OJJDP expects applicants to review the research literature for relevant studies, they should also explore whether unpublished local sources of information, research, or evaluation data are available.

b. Project Design and Implementation

Applicants should detail how the project will operate throughout the funding period, describe the strategies that they will use to achieve identified goals and objectives, and complete the deliverables identified in the solicitation's Goals, Objectives, and Deliverables section. Applicants should clearly identify how they will address these goals and objectives by outlining specific, quantifiable statements of the project's desired results and clearly linking strategies to the problem identified in the preceding section. Applicants should describe the proposed plans for planning and delivering a nationally coordinated system of TTA, region-specific assessments, and development and delivery of specific TTA capacity to the region. While the TTA processes may need to be coordinated as a first key deliverable in conjunction with the other regional awardees, applicants should describe their capacity and plans to develop and deliver TTA in specific and measurable terms as it relates to the proposed budget. (e.g., applicants may define the capacity to deliver TTA such as conduct X assessments and X individual TTA plans, develop X curricula of a specific size and scope, deliver in-person training to X locations or X persons, develop X number of train-the-trainer tools and disseminate to X number of trainers, develop X online modules or courses). Applicants should address each deliverable in the project design section and the related timeline described below. All TTA activities should be defined in enough specificity to describe the type, scope, method, duration, or intensity of the activity as well as the intended audience, number, and frequency of the activities (if reoccurring). All TTA support should be skill-focused with measurable outcomes and include plans for evaluating the TTA activity.

OJJDP encourages applicants to select evidence-based practices for their programs. This section should also include details regarding any leveraged resources (cash or in-kind) from local sources to support the project and align and maximize resources in a most cost-effective manner. OJJDP also encourages applicants to discuss plans for sustainability beyond the grant period.
