Overview

The <u>U.S. Department of Justice</u> (DOJ), <u>Office of Justice Programs</u> (OJP), <u>Office of Juvenile Justice and Delinquency Prevention</u> (OJJDP) seeks applications for funding to increase the technological investigative capacity and associated training of Internet Crimes Against Children (ICAC) task force personnel nationwide through the development, refinement, and advancement of widely used investigative tools, methods, and technologies that address child pornography (herein referred to as child sexual abuse material - CSAM), exploitation, and sex trafficking. This program furthers the DOJ's mission by supporting the efforts of law enforcement and prosecutors to combat crimes against children.

This solicitation incorporates guidance provided in the OJP Grant Application Resource Guide, which provides additional information for applicants to prepare and submit applications to OJP for funding. If this solicitation expressly modifies any provision in the OJP Grant Application Resource Guide, the applicant is to follow the guidelines in this solicitation as to that provision.

Program Description

Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

OJJDP's guiding philosophy is to enhance the welfare of America's youth and broaden their opportunities for a better future. To bring these goals to fruition, OJJDP is leading efforts to transform the juvenile justice system into one that will Ireat Children as Children; Serve Children at Home, With Their Families, in their Communities; and Open Up Opportunities for System-Involved Youth. OJJDP encourages all proposed applications that work with youth to highlight how the proposed program aligns with these priorities.

OJJDP envisions a juvenile justice system centered on the strengths, needs, and voices of youth and families. Young people and family members with lived experience are vital resources for understanding and reaching persons involved or at risk of involvement with youth-serving systems. OJJDP asks stakeholders to join us in sustainably integrating bold, transformative youth and family partnership strategies into our daily work. OJJDP believes in achieving positive outcomes for youth, families, and communities through meaningful engagement and active partnerships, ensuring they play a central role in collaboratively developing solutions.

With this solicitation, OJJDP seeks to provide funding for applicant organizations to increase the technological investigative capacity of ICAC task forces and their affiliates as well as related state, Tribal, and local law enforcement and prosecutorial agencies through training and the development and/or enhancement of widely used investigative tools, methods, and technologies that address child sexual abuse material (CSAM) and online child exploitation.

Statutory Authority

Department of Justice Appropriations Act, 2023, Pub. L. No. 117-328, 136 Stat. 4459, 4539.

Specific Information

OJJDP has supported the ICAC Task Force Program since 1998. The ICAC Task Force Program supports a national network of 61 multiagency, multijurisdictional task forces engaged in investigations, forensic examinations, and prosecutions related to

technology-facilitated child sexual exploitation. Additionally, the task forces provide forensic and investigative technical assistance to law enforcement and prosecutorial officials. The ICAC Task Force Program also provides community education information to parents, educators, prosecutors, law enforcement, and others concerned with understanding the technological challenges of investigating and prosecuting child sexual exploitation matters.

There are three categories of funding under this solicitation:

Category 1: Investigative Tool and Technology Development – Develop new and innovative widely used investigative tools, methods and technologies for law enforcement, prosecutors, and other professionals that address child sexual abuse material, child sexual exploitation, and child sex trafficking nationwide. The development of these tools will help the law enforcement community and prosecutorial agencies nationwide to overcome current technology-related investigative challenges. Examples of such tools include, but are not limited to, those that efficiently and effectively parse through digital evidence; expedite evidence collection and the transfer of digital files; facilitate decryption; address mobile chat encryptions; automate data intelligence; and support ICAC case management, case deconfliction, and high-priority suspect identification. In addition, this category will support the development of tools that assist the law enforcement community nationwide in overcoming challenges in covert operations; provide national reporting and information-sharing capabilities among federal, state, local, and Tribal law enforcement (particularly ICAC task forces); and support peerto-peer investigations.

Category 2: Investigative Tool and Technology Enhancement – Enhance and/or refine existing widely used investigative tools, methods, and technologies for law enforcement, prosecutors, and other professionals that address child sexual abuse material, child sexual exploitation, and child sex trafficking nationwide. Improvements to these widely used tools will help the law enforcement community and prosecutorial agencies nationwide to overcome current technology-related investigative challenges. Examples of such tools include, but are not limited to, effective interviewing tactics (to include polygraphs) to ascertain whether an offender has previously engaged in hands-on abuse; case deconfliction tools; high-priority suspect identification; covert operation tools; national reporting and information sharing capabilities among federal, state, local, and Tribal law enforcement (particularly ICAC task forces); evaluation of existing technical resources and tools; and peer-to-peer investigative tools.

Category 3: Investigative Tool and Technology Training – Develop and deliver new training and/or advanced skills training for the law enforcement community and prosecutorial agencies nationwide on tools, methods, and technologies that address child sexual abuse material, exploitation, and sex trafficking. Applicants can propose to develop and deliver new training curricula to deliver content through multiple cost-effective delivery mechanisms.

Goals, Objectives, and Deliverables

Goals

The goal of this program is to increase the technological investigative capacity and associated training of law enforcement, prosecutors, and other professionals nationwide to combat CSAM and online child sexual exploitation, including cases of child sex trafficking.

Objectives

An applicant should address all the objectives that are relevant to their proposed program/project in the Goals, Objectives, Deliverables, and Timeline web-based form.

OJJDP has developed the following program objectives.

<u>Category 1</u> - Support the development of widely used investigative tools, methods, and technologies that address CSAM and online child sexual exploitation, including cases of child sex trafficking.

<u>Category 2</u> - Support the enhancement and/or refinement of widely used investigative tools, methods, and technologies that address CSAM and online child sexual exploitation, including cases of child sex trafficking.

<u>Category 3</u> - Increase the amount and availability of new skill-based training for the law enforcement community and prosecutorial agencies nationwide on widely used tools, methods, and technologies that address CSAM and online child sexual exploitation, including cases of child sex trafficking.

To achieve these objectives, it is expected that the successful applicant for any of the three categories will address the following in the "Project Design and Implementation" section of their program narrative:

- Outline and describe the proposed investigative tools, methods, or technologies and/or describe the proposed training for the law enforcement community and prosecutorial agencies nationwide on tools, methods, and technologies.
- Identify the gaps or planned improvements in existing investigative tools, methods, and technologies that the proposed product and/or training will address.
- Demonstrate that they have consulted with criminal justice agencies to gain a fuller understanding of any challenges and the operational context within which these tools would be employed.
- Indicate how the proposed product will target emerging technologies, target offender organizations, target high-value individual offenders, better identify victims, or enhance international collaboration.

OJJDP encourages applicants, especially those who propose coalition-building and support, work with pilot sites, or work with project partners as part of their activities, to clearly document support and engagement from their proposed and/or existing partners through letters of support and/or memoranda of understanding (MOU), where appropriate.

Deliverables

The following lists the required deliverables, such as expected products, services, or activities that should be developed/delivered as a result of this program:

For all three categories:

- Develop a timeline/work plan for the development, refinement, and advancement of the proposed investigative tools, methods, technologies, or training.
- Develop a plan for how the proposed product or training will be marketed and made available to law enforcement, prosecutors, and other professionals on a nationwide basis.
- Create a sustainability plan for the proposed product.

<u>Category 1</u>: Development of widely used investigative tools, methods, and technologies that address CSAM and child sexual exploitation.

<u>Category 2:</u> Enhancement and/or refinement of widely used investigative tools, methods, and technologies that address CSAM and child sexual exploitation.

<u>Category 3</u>: Development and delivery of new and/or advanced training for the law enforcement community and prosecutorial agencies nationwide on tools, methods, and technologies that address CSAM, exploitation, and sex trafficking. Applicants are expected to develop curricula, create an agenda, identify instructors/speakers, select training sites, provide logistical support, and execute each training event. Proposals may employ traditional classroom, hands-on laboratory-based, web-based, or other mechanisms for training delivery, depending on the objectives of the training program.

Funding under this initiative may support technology development and maintenance; the staff required to operate, update, and maintain the proposed platform or service; training and technical assistance on the purpose and use of the technology (including outreach and publicity activities); and staff engaged in coalition-building activities regarding the use of technology. Trainings must be provided at no charge to the participants; costs associated with travel and lodging for the trainers must be included in the budget.

The Goals, Objectives, and Deliverables are directly related to the performance measures that show the completed work's results, as discussed in the "Application and Submission Information" section.

A. Applications that propose project(s) that are designed to promote racial equity and the removal of barriers to access and opportunity for communities that have been historically underserved, marginalized, and adversely affected by inequality.

To receive this consideration, the applicant must describe how the proposed project(s) will address potential racial inequities and contribute to greater access to services and opportunities for communities that have been historically underserved, marginalized, and adversely affected by inequality, and identify how the project design and implementation will specifically incorporate the input or participation of those communities and populations disproportionately impacted by crime, violence, and the criminal justice system overall. Examples addressing this requirement include, but are not limited to, the following: budgeted project planning and/or implementation meetings with community stakeholders representing historically underserved and marginalized communities; outreach and/or public awareness campaigns specifically tailored to historically underserved and marginalized communities to encourage participation in the proposed project(s); budgeted incorporation of members representing historically underserved and marginalized communities in program evaluation, surveys, or other means of project feedback; and partnership with organizations that primarily serve communities that have been historically underserved, marginalized, and adversely affected by inequality.

B. Applicants that demonstrate that their capabilities and competencies for implementing their proposed project(s) are enhanced because they (or at least one proposed subrecipient that will receive **at least 40%** of the requested award funding, as demonstrated in the Budget Web-Based Form) identify as a *culturally specific* organization.

To receive this additional priority consideration, applicants must describe how being a culturally specific organization (or funding the culturally specific subrecipient organization (s)) will enhance their ability to implement the proposed project(s) and should also specify which populations are intended or expected to be served or to have their needs addressed under the proposed project(s).

Culturally specific organizations are defined for the purposes of this solicitation as private nonprofit or Tribal organizations whose primary purpose as a whole is to provide culturally specific services to racial and ethnic groups, including, among others, Black people, Hispanic and Latino people, Native American and other Indigenous peoples of North America (including Alaska Native, Eskimo, and Aleut), Asian Americans, Native Hawaiians, and/or Pacific Islanders.

A Proposal Abstract (no more than 400 words) summarizing the proposed project — including its purpose, primary activities, expected outcomes, the service area, intended beneficiaries, and subrecipients (if known) — must be completed in the JustGrants webbased form. This abstract should be in paragraph form without bullets or tables, written in the third person, and exclude personally identifiable information. Abstracts will be made publicly available on the OJP and USASpending.gov websites if the project is awarded. See the OJP Grant Application Resource Guide for an example of a proposal abstract.

Proposal Narrative

The Proposal Narrative should be submitted as an attachment in JustGrants. The attached document should be double-spaced, using a standard 12-point font; have no less than 1-inch margins; and should not exceed 30 numbered pages. If the Proposal Narrative fails to comply with these length restrictions, OJJDP may consider such noncompliance in peer review and in final award decision.

The Proposal Narrative must include the following sections:

a. Description of the Issue

Applicants should briefly describe the scope of technology-facilitated crimes against children across the country; the need to investigate these crimes; and the need for support, training, and tools to increase law enforcement and prosecutorial capacity to investigate and prosecute Internet crimes against children. The applicant should use data to provide evidence that the problem exists, demonstrate the size and scope of the problem, and document the effects of the problem on the target population and the larger community. Applicants must demonstrate that they have consulted with criminal justice agencies to gain a fuller understanding of these challenges and the operational context within which these tools would be employed. Any data or research referenced in the narrative should include information about the source of the data and/or a citation. Applicants should describe any research or evaluation studies that relate to the problem and contribute to their understanding of its causes and potential solutions. While OJJDP expects applicants to review the research literature for relevant studies, they should also explore whether unpublished local sources of research or evaluation data are available.

b. Project Design and Implementation

Applicants should detail how the project will operate throughout the funding period and describe the strategies that they will use to achieve the goals and objectives identified in the previous section. Applicants should describe how they will complete the deliverables stated in the Goals, Objectives, and Deliverables section. OJJDP encourages applicants to select evidence-based practices for their programs. This section should also include details regarding any leveraged resources (cash or in-kind) from local sources to support the project and discuss plans for sustainability beyond the grant period.

If the applicant is seeking priority consideration for Priority 1(A), it should address in this section how the proposed project(s) will promote racial equity and the removal of barriers to access and opportunity for communities that have been historically underserved, marginalized, and adversely affected by inequality, and identify how the project design and implementation will specifically incorporate the input or participation of these communities.

c. Capabilities and Competencies

This section should describe the experience and capability of the applicant organization and any contractors or subgrantees that the applicant will use to implement and manage this effort and its associated federal funding, highlighting any previous experience implementing projects of similar design or magnitude. Applicants should highlight their experience/capability/capacity and success in the development and/or delivery of training for law enforcement and prosecutorial agencies nationally as well as their experience in managing subawards, including details on their system for fiscal accountability. Management and staffing patterns should be clearly connected to the project design described in the previous section. Applicants should describe the roles and responsibilities of project staff and explain the program's organizational structure and operations. Applicants should include a copy of an organizational chart showing how the organization operates, including who manages the finances; how the organization manages subawards, if there are any; and the management of the project proposed for funding.

If the applicant is seeking priority consideration under Priority 1(B), it should describe within this section how being a culturally specific organization (or funding a culturally specific subrecipient organization at a minimum of 40% of the project budget) will enhance its ability to implement the proposed project(s), should also specify which populations are intended or expected to be served or have their needs addressed under the proposed project(s), and should include the website address (if applicable) and formal or informal mission statement or principles of the culturally specific organization.

d. Plan for Collecting the Data Required for this Solicitation's Performance Measures

Describe the process for measuring project performance. Identify who will collect the data, who is responsible for performance measurements, and how the information will be used to guide and evaluate the impact of the project. Describe the process that will be used to accurately report data.

Note: An applicant is **not** required to submit performance data with the application. - 1. Description of the Issue (10%) evaluate the applicant's understanding of the program/issue to be addressed.
- 2. Project Design and Implementation (45%)- evaluate the adequacy of the proposal, including the goals, objectives, timelines, milestones, and deliverables.
- 3. Capabilities and Competencies (30%) evaluate the applicant's administrative and technical capacity to successfully accomplish the goals and objectives.
- 4. Plan for Collecting the Data Required for this Solicitation's Performance Measures (10%) evaluate the applicant's understanding of the performance data reporting requirements and the plan for collecting the required data.
- 5. Budget (5%) evaluate for completeness, cost effectiveness, and allowability (e.g., reasonable, allocable, and necessary for project activities).

Other Review Criteria/Factors
