Overview

The [U.S. Department of Justice](#) (DOJ), [Office of Justice Programs](#) (OJP), [Office of Juvenile Justice and Delinquency Prevention](#) (OJJDP) seeks applications for funding to implement Juvenile Justice and Delinquency Prevention Act Outreach and Education Community Awareness Projects in recognition of the 50th anniversary of the passage of the Juvenile Justice and Delinquency Prevention (JJDP) Act. This program furthers the DOJ's mission by highlighting local delinquency prevention and youth justice efforts by increasing communication and enhancing information sharing across stakeholders.

This solicitation incorporates guidance provided in the [OJP Grant Application Resource Guide](#), which provides additional information for applicants to prepare and submit applications to OJP for funding. **If this solicitation expressly modifies any provision in the OJP Grant Application Resource Guide, the applicant is to follow the guidelines in this solicitation as to that provision.**

Eligible Applicants:

Nonprofits having a 501(c)(3) status with the IRS, other than institutions of higher education, Nonprofits that do not have a 501(c)(3) status with the IRS, other than

OJJDP will consider applications under which two or more entities would carry out the federal award; however, only one entity may be the applicant. OJJDP may elect to fund applications submitted under this FY 2023 solicitation in future fiscal years, dependent on, among other considerations, the merit of the applications and the availability of appropriations.

Submission Information

Program Description

Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

[OJJDP's](#) guiding philosophy is to enhance the welfare of America's youth and broaden their opportunities for a better future. To bring these goals to fruition, OJJDP is leading efforts to transform the juvenile justice system into one that will [Treat Children as Children](#); [Serve Children at Home, With Their Families, in their Communities](#); and [Open Up Opportunities for System-Involved Youth](#). OJJDP encourages all proposed applications that work with youth to highlight how the proposed program aligns with these priorities.

OJJDP envisions a juvenile justice system centered on the strengths, needs, and voices of youth and families. Young people and family members with lived experience are vital resources for understanding and reaching persons involved or at risk of involvement with youth-serving systems. OJJDP asks stakeholders to join us in sustainably integrating bold, transformative youth and family partnership strategies into our daily work. OJJDP believes in achieving positive outcomes for youth, families, and communities through meaningful engagement and active partnerships, ensuring they play a central role in collaboratively developing solutions.

Applicants must describe how their proposed project/program will integrate and sustain meaningful youth and family partnerships into their project plan and budget. Depending on the nature of an applicant's proposed project, youth and family partnership could consist of one or more of the following:

- Individual-level partnership in case planning and direct service delivery (before, during, and after contact with youth-serving systems).
- Agency-level partnership (e.g., in policy, practice, and program development, implementation, and evaluation; staffing; advisory bodies; budget development).
- System-level partnership (e.g., in strategic planning activities, system improvement initiatives, advocacy strategies, reform efforts).

With this solicitation, OJJDP seeks to commemorate the 50th anniversary of the passage of the JJDP Act by enabling an organization to provide financial and technical assistance to an estimated 75 to 100 communities nationwide, reflecting all 50 states, the territories, and the District of Columbia. These subgrants will help to cover the costs associated with convening local youth justice serving agencies and organizations, impacted youth and

families, local leaders, and other stakeholders for the purpose of sharing information about the JJDP Act, local delinquency prevention resources, juvenile justice system activities, Youth Justice Action Month, and emerging issues in the community. All final decisions as to which communities will be funded by the intermediary will be made by OJJDP.

Statutory Authority

Department of Justice Appropriations Act, 2023, Pub. L. No. 117-328, 136 Stat. 4459, 4538.

Specific Information

To further assist communities in their efforts to conduct public education and awareness activities highlighting the JJDP Act, delinquency prevention, and youth justice, OJJDP will provide funding to an entity that will make subawards to communities for projects to provide education and awareness related to preventing juvenile delinquency and promoting youth justice and to serve as the technical assistance provider to the competitively selected subgrantees. The purpose of these subrecipient community education and awareness events is to:

- Provide an opportunity for juvenile justice agencies, local coalitions, youth serving organizations, and community members to strengthen local partnerships and work together toward local solutions to prevent youth delinquency, risk behavior and victimization.
- Educate the relevant local community members regarding best practices and evidence-based strategies in delinquency prevention and intervention, as well as providing opportunities for further engagement in developing solutions.
- Increase public awareness of the Juvenile Justice and Delinquency Prevention (JJDP) Act and the Office of Juvenile Justice and Delinquency Prevention, including how to request resources and assistance.

The recipient will work cooperatively with OJJDP in the application development, review and selection process for the community education and awareness projects. These community education and awareness projects are to be designed to meaningfully engage youth at risk of delinquency, as well as the larger local youth serving community in ways that share information about best practices in delinquency prevention and emphasize prevention and early intervention approaches to youth risk behavior. The recipient will develop and provide a tool kit that provides background information about the JJDP Act, delinquency prevention, and youth justice, as well as guidance for subgrantees in implementing their projects in ways that further the goal of delinquency prevention.

Subrecipient Eligibility: Public agencies, nonprofit organizations, community-based organizations, faith-based organizations, Tribal organizations. A nonprofit organization

does not need to have 501(c)(3) status to apply. Applicants selected for funding will be required to submit an after-action report on their activities, including data on performance measures and financial outlays.

Subrecipient Information: In their applications, the subrecipients must discuss how the activities they propose to undertake as part of this program will contribute to the local community goal of delinquency prevention. Subrecipients may be approved for up to \$5,000 in reimbursement under this funding for the types of activities listed below:

- Host film screening, book talk, art exhibit, spoken word performance, or similar activity.
- Design, print, and disseminate educational resources and promotional materials regarding the activities and events.
- Reimburse event speakers' fees (NOT to exceed \$650 per day for each speaker). Supplemental funding from other sources cannot be used to exceed this daily limitation.
- Rent space to conduct activities and events.
- Purchase supplies, materials, and equipment used in public education and awareness events and activities.

The following reimbursements will NOT be approved for subrecipients:

- Salaries.
- Organizational overhead or operational costs.
- Refreshment costs not associated with public awareness events or programs.
- Costs associated with a fundraising activity or event.
- Bar charges or alcoholic beverages.
- Food and beverage costs associated with award events or ceremonies.
- Construction costs.
- Cash prizes, including gift cards, associated with contests, raffles, or drawings.
- Costs associated with promotional and educational materials that are not directly tied to the project.

Goals, Objectives, and Deliverables

Goals

The goals of this project are to increase public education and awareness about the JJDP Act, juvenile delinquency prevention, Youth Justice Action Month, and related activities across the nation.

Objectives

An applicant should address all of the objectives listed below in the Goals, Objectives, Deliverables, and Timeline web-based form.

Objective 1: Financially, programmatically, and administratively support 75 to 100 subgrants of up to \$5,000 each for communities nationwide.

Objective 2: Provide technical assistance for the subrecipient organizations, where needed. Technical assistance should cover the planning, implementation, communication and dissemination of specific public education and awareness events and activities.

Objective 3: Market the project so that it meets the goal of funding at least one project in every state and U.S. territory and ensures that Tribal communities are included. A diverse range in terms of population and geographic location should be reflected in the selected communities.

Objective 4: Assemble a group of expert reviewers willing to volunteer their services to review every application received and be a part of the selection process.

Deliverables

Project activities and deliverables include the following:

- Develop and administer the community education and awareness project outreach and application processes (final recommendations require the approval of OJJDP).
- Advertise and publicize the application period through OJJDP and other public venues. Establish a Review Committee to review, grade, and comment on each application submitted. The Review Committee should meet, either in person or virtually, after all applications are scored to determine which applications will move forward for final approval.
- Establish a website to advertise the funding opportunity, provide FAQs for first-time applicants, and link to the main OJJDP website.
- Provide funding recommendations from the Review Committee to OJJDP for final decision.
- Reimburse selected subrecipients.
- Provide technical assistance to each selected subrecipient.
- Receive, review, and summarize after-action reports, including documentation and verification of expenses and requests for reimbursement.
- Prepare a final report for OJJDP on the overall project, including recommendations for improvement and a list of innovative practices for inclusion in future OJJDP Resource Guides.

The Goals, Objectives, and Deliverables are directly related to the performance measures that show the completed work's results, as discussed in the "Application and Submission Information" section.

1. Priority Considerations Supporting Executive Order 13985, *Advancing Racial Equity and Support for Underserved Communities Through the Federal Government*

In support of this [Executive Order](#), OJP will provide priority consideration when making award decisions to the following:

A. Applications that propose project(s) that are designed to promote racial equity and the removal of barriers to access and opportunity for communities that have been historically underserved, marginalized, and adversely affected by inequality.

To receive this consideration, the applicant must describe how the proposed project(s) will address potential racial inequities and contribute to greater access to services and opportunities for communities that have been historically underserved, marginalized, and adversely affected by inequality, and identify how the project design and implementation will specifically incorporate the input or participation of those communities and populations disproportionately impacted by crime, violence, and the criminal justice system overall. Examples addressing this requirement include, but are not limited to, the following: budgeted project planning and/or implementation meetings with community stakeholders representing historically underserved and marginalized communities; outreach and/or public awareness campaigns specifically tailored to historically underserved and marginalized communities to encourage participation in the proposed project(s); budgeted incorporation of members representing historically underserved and marginalized communities in program evaluation, surveys, or other means of project feedback; and partnership with organizations that primarily serve communities that have been historically underserved, marginalized, and adversely affected by inequality.

B. Applicants that demonstrate that their capabilities and competencies for implementing their proposed project(s) are enhanced because they (or at least one proposed subrecipient that will receive **at least 40%** of the requested award funding, as demonstrated in the Budget Web-Based Form) identify as a *culturally specific organization*.

To receive this additional priority consideration, applicants must describe how being a culturally specific organization (or funding the culturally specific subrecipient organization (s)) will enhance their ability to implement the proposed project(s) and should also specify which populations are intended or expected to be served or to have their needs addressed under the proposed project(s).

Culturally specific organizations are defined for the purposes of this solicitation as private nonprofit or Tribal organizations whose primary purpose as a whole is to provide culturally specific services to racial and ethnic groups, including, among others, Black people, Hispanic and Latino people, Native American and other Indigenous peoples of North America (including Alaska Native, Eskimo, and Aleut), Asian Americans, Native Hawaiians, and/or Pacific Islanders.

Note: Addressing these priority areas is one of many factors that OJP considers in making funding decisions. Receiving priority consideration for one or more priority areas does not guarantee an award.

If OJP determines that an application does not include these elements, it will neither proceed to peer review, nor receive further consideration.

Information to Complete the Application for Federal Assistance (SF-424) in Grants.gov

Proposal Abstract

A Proposal Abstract (no more than 400 words) summarizing the proposed project — including its purpose, primary activities, expected outcomes, the service area, intended beneficiaries, and subrecipients (if known) — must be completed in the JustGrants web-based form. This abstract should be in paragraph form without bullets or tables, written in the third person, and exclude personally identifiable information. Abstracts will be made publicly available on the OJP and USASpending.gov websites if the project is awarded. See the [OJP Grant Application Resource Guide](#) for an example of a proposal abstract.

Proposal Narrative

The proposal narrative should be submitted as an attachment in JustGrants. The attached document should be double-spaced, using a standard 12-point font; have no less than 1-inch margins; and should not exceed 30 numbered pages. If the proposal narrative fails to comply with these length restrictions, OJJDP may consider such noncompliance in peer review and in final award decision.

The proposal narrative must include the following sections:

- a. Description of the Issue

Describe why these proposed activities (a series of community education, outreach, and awareness events around juvenile justice, delinquency prevention, and the JJDP Act) are necessary and address a need by highlighting local delinquency prevention and youth justice efforts and will enhance information sharing across stakeholders. Include supporting information.

b. Project Design and Implementation

List the activities and describe how they relate to the stated objectives. Activities are the specific actions to be undertaken to fulfill the program's objectives and reach the program's goal(s). Provide a detailed description of the method(s) to be used to carry out each activity. Provide a timetable indicating roughly when the activities or program milestones are to be accomplished.

Applicants should describe their vision and plan for meaningfully and sustainably integrating youth and family partnership into their proposed project. Applicants should address any corresponding budget implications in their application's budget detail and budget narrative. For resources/guidance on effective youth and family partnership strategies and practices, click [here](#).

If an applicant believes that their project design is in no way amenable to incorporating youth and family partnership, the applicant should instead provide a detailed explanation and justification for excluding this element.

If the applicant is seeking priority consideration for Priority 1(A), it should address in this section how the proposed project(s) will promote racial equity and the removal of barriers to access and opportunity for communities that have been historically underserved, marginalized, and adversely affected by inequality, and identify how the project design and implementation will specifically incorporate the input or participation of these communities.

c. Capabilities and Competencies

Describe the capabilities and competencies required to accomplish the goals and objectives of the project. Describe the experience and capability of the applicant organization and partners or subgrantees that will be used to implement and manage this effort and its associated federal funding, highlighting any previous experience implementing projects of similar design or magnitude. Highlight the applicant organization's experience/capability/capacity to manage subawards, including details on the agency's system for fiscal accountability. Explain how the management and staffing patterns connect to the project design described in the previous section. Describe the roles and responsibilities of project staff and explain the program's organizational structure and operations. Include a copy of an organizational chart showing how the organization operates, including who

manages the finances; how the organization manages subawards, if there are any; and the management of the project proposed for funding.
