#### Overview

The <u>U.S. Department of Justice</u> (DOJ), <u>Office of Justice Programs</u> (OJP), <u>Office of</u> <u>Juvenile Justice and Delinquency Prevention</u> (OJJDP) seeks applications for a national training and technical assistance provider to support jurisdictions' efforts to improve juvenile records expungement and sealing in order to eliminate barriers to successful reentry. This program furthers the DOJ's mission to keep our country and communities safe and protect civil rights and civil liberties by supporting efforts to eliminate barriers to successful reentry and recidivism reduction.

#### **Program Description**

#### Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

With this solicitation, OJJDP seeks to select a national training and technical assistance provider to support jurisdictions' efforts to improve juvenile records expungement and sealing in order to eliminate barriers to their successful reentry and ensure that they are afforded the genuine second chances upon which the juvenile justice system is predicated.

<u>OJJDP's</u> guiding philosophy is to enhance the welfare of America's youth and broaden their opportunities for a better future. To bring these goals to fruition, OJJDP is leading efforts to transform the juvenile justice system into one that will <u>Treat Children as</u> <u>Children</u>; <u>Serve Children at Home, With Their Families, in their Communities</u>; and <u>Open</u> <u>Up Opportunities for System-Involved Youth</u>. OJJDP encourages all proposed applications that work with youth to highlight how the proposed program aligns with these priorities.

OJJDP envisions a juvenile justice system centered on the strengths, needs, and voices of youth and families. Young people and family members with lived experience are vital resources for understanding and reaching persons involved or at risk of involvement with youth-serving systems. OJJDP asks stakeholders to join us in sustainably integrating bold, transformative youth and family partnership strategies into our daily work. OJJDP believes in achieving positive outcomes for youth, families, and communities through meaningful engagement and active partnerships, ensuring they play a central role in collaboratively developing solutions.

Applicants must describe how their proposed project/program will integrate and sustain meaningful youth and family partnerships into their project plan and budget. Depending on the nature of an applicant's proposed project, youth and family partnership could consist of one or more of the following:

- Individual-level partnership in case planning and direct service delivery (before, during, and after contact with youth-serving systems).
- Agency-level partnership (e.g., in policy, practice, and program development, implementation, and evaluation; staffing; advisory bodies; budget development).
- System-level partnership (e.g., in strategic planning activities, system improvement initiatives, advocacy strategies, reform efforts).

#### **Statutory Authority**

Department of Justice Appropriations Act, 2023, Pub. L. No. 117-328, 136 Stat. 4459, 4536; Section 101 of the Second Chance Act of 2007 (Pub. L. No. 110–199; Pub. L. No. 115–391; 34 U.S.C. § 10631) ; 28 U.S.C. 530C.

#### **Specific Information**

In 2019, U.S. courts handled an estimated 722,600 cases in which a youth was charged with a delinquency offense, with hundreds of thousands more on probation.[1] A record can trigger collateral consequences that impede adolescents' development and prospects for long-term success. Records of their arrest, charge, and disposition may appear on background checks run by employers, landlords, colleges, lenders, the military, and vocational licensing bodies, resulting in discrimination and exclusion. Expunging these records helps young people who are reentering their communities obtain educational loans and realize educational attainment, maintain gainful employment and secure housing, access credit, obtain occupational licenses, and address a host of other factors critical to their successful reentry and transition into adulthood. A Presidential Proclamation on Second Chance Month 2022 affirms the vital importance of record expungement to persons reentering their communities following confinement:

America is a Nation of second chances, and it is critical that our criminal and juvenile justice systems provide meaningful opportunities for rehabilitation and redemption. ... My Administration recognizes that making the criminal and juvenile justice systems more equitable, just, and effective requires...expunging and sealing certain criminal records so that people's futures are not defined by their past. ... By supporting people who are committed to rectifying their mistakes, redefining themselves, and making meaningful contributions to society, we help reduce recidivism and build safer communities. ... That is why my Administration is working across Federal agencies to eliminate barriers to reentry. ... Together, let us recommit to empower Americans who have paid their debt to society and to provide them with a second chance to participate, contribute, and succeed.<sup>[2]</sup>

The barriers that juvenile records pose are debilitating for individual young people and undermine the purpose and efficacy of the juvenile justice system. Our juvenile justice system is predicated on the principle that youth are developmentally different from adults and are more amendable to effective interventions, treatment, and rehabilitation. The juvenile justice system relies upon the genuine second chances that our young people are afforded when their youthful acts are not permitted to follow them into adulthood.

A 2019 research study at the University of Michigan found that only 6.5% of eligible individuals actually received expungements within five years of eligibility. The study also found that only 7% of all expungement recipients were rearrested within five years of receiving their set-aside (just 2.6% for violent offenses) and even fewer are reconvicted,

Page 8 of 33 O-OJJDP-2023-171734 which are extremely low recidivism rates in comparison with the general population. Finally, this study found that individuals' set-asides were associated with an average 25% wage increase within two years of expungement. Another research study found that expungements reduced barriers to employment, led to cognitive improvements and a feeling of a new identity, and led to monetary net benefits for recipients (\$5,760 per individual each year).<sup>[3]</sup> For young people reentering their communities, expunging records helps them obtain and realize educational attainment, employment and secure housing, resulting in lower recidivism rates and higher successful transitions to adulthood.

Despite the many benefits of expungement, a number of barriers prevent most young people from expunging their records. Examples include a dearth of automatic expungement laws specifically for records obtained when someone was a child or youth, a lack of knowledge and awareness about the availability and importance of expungement remedies, the absence of data tracking and notification systems, and a grave dearth of lawyers trained and resourced to help young poeple through the legal process. All of these barriers disproportionately impact young people of color and low-income young people, who are overrepresented in the justice system. Justice system involvement should benefit young people, not create additional obstacles in their lives. Ensuring that young people's reentry and future opportunities are not hindered by juvenile records enables young people to secure the tools and opportunities essential to transitioning into adulthood and avoiding further system involvement.

The purpose of this program is to help jurisdictions interested in juvenile reentry projects improve how they expunge, seal, or vacate juvenile records in order to eliminate barriers to successful reentry, improve youth outcomes, reduce recidivism, and enhance public safety.

#### **Goals, Objectives, and Deliverables**

#### Goals

The goal of this program is to help jurisdictions interested in juvenile reentry projects improve their records expungement and sealing policies, programs, practices, and resources for young poeple. Recognizing that the breadth and reach of juvenile court records far exceed the capacity of young people,

youth defense delivery systems, or juvenile courts to meaningfully address strictly on an individual, case-by-case basis and that individual record-clearance efforts too often financially burden young people and families and add to juvenile courts' and youth defense delivery systems' overwhelming caseloads, a primary goal of this program is to increase the type and number of juvenile court records eligible for automatic expungement, expunction, and/or sealing.

#### Objectives

An applicant should address all of the objectives listed below in the Goals, Objectives, Deliverables, and Timeline web-based form.

The national training and technical assistance (TTA) provider will provide training, technical assistance, and resources to jurisdictions interested in juvenile reentry projects seeking to improve their juvenile records expungement and sealing policies, programs, practices, and resources.

Focus areas the TTA provider should help jurisdictions to address include, but are not limited to:

- Expanding policies and implementation for the use of automatic juvenile record clearance.
- Identifying and eliminating systemic barriers to expungement (such as arbitrary or excessive age requirements and disqualifying factors, excessive waiting periods, onerous filing fees and requirements, and extremely complicated processes).
- Providing training and information to judges, court personnel, defenders, civil legal services providers, lawmakers, and/or other persons and entities poised to improve or assist with juvenile records clearance.
- Implementing tracking and notification systems to ensure young poeple and families are informed when a young person becomes eligible for expungement.
- Developing and implementing data collection frameworks and protocols to collect, analyze, and publish expungement-related data and use that data in decisionmaking.
- Educating/informing young people and families about the importance of records sealing and expungement as a way to provide better opportunities for young people and avoid recidivism.
- Providing direct legal assistance to young poeple and their families with the expungement process.
- Raising awareness nationally of other available resources (such as National Criminal History Improvement, or "NCHIP," funds) that can be used by states to seal or expunge juvenile and criminal history information in accordance with state laws and policies.

#### Deliverables

Deliverables include, but are not limited to:

- Expanded use of automatic juvenile record clearance across jurisdictions.
- Publications, tools, practice guides, and/or other resources addressing the relevance and importance of expungement and record sealing; the harmful collateral consequences juvenile records have on reentering children and families; and curating best and promising record clearance policies, practices, and models.
- Training and technical assistance for judges, court personnel, defenders, civil legal services providers, lawmakers, and other persons and entities poised to improve or assist with juvenile records clearance.
- Data analyses and system assessments pertaining to juvenile records clearance to inform and spur reform.
- A national publication that summarizes the TTA project; objectively assesses or evaluates the impact of the implemented strategies; and captures early outcomes, lessons learned, and best and promising practices. The purpose of this culminating deliverable is to inform and inspire other jurisdictions to pursue juvenile record clearance reform. The publication should be accompanied by a dissemination strategy (which could include, for example, a national webinar or webinar series, bulletins, a podcast series, or workshops at relevant annual conferences).

The TTA provider will collaborate closely with organizations conducting work in this area as well as relevant DOJ-funded providers, such as the Second Chance Youth Reentry National Training and Technical Assistance provider and the National Reentry Resource Center, to leverage this work and expand its reach.

The Goals, Objectives, and Deliverables are directly related to the performance measures that show the completed work's results, as discussed in the "Application and Submission Information" section.

#### **OJJDP Training and Technical Assistance Awardee Standards**

OJJDP has developed the Core Performance Standards for Training, Technical Assistance, and Evaluation to promote among providers the consistency and quality of OJJDP-sponsored training and technical assistance and to advance common expectations of performance excellence. Examples addressing this requirement include, but are not limited to, the following: budgeted project planning and/or implementation meetings with community stakeholders representing historically underserved and marginalized communities; outreach and/or public awareness campaigns specifically tailored to historically underserved and marginalized communities in program evaluation, surveys, or other means of project feedback; and partnership with organizations that primarily serve communities that have been historically underserved, marginalized, and adversely affected by inequality.

B. Applicants that demonstrate that their capabilities and competencies for implementing their proposed project(s) are enhanced because they (or at least one proposed subrecipient that will receive **at least 40%** of the requested award funding, as demonstrated in the Budget Web-Based Form) identify as a *culturally specific organization*.

To receive this additional priority consideration, applicants must describe how being a culturally specific organization (or funding the culturally specific subrecipient organization (s)) will enhance their ability to implement the proposed project(s) and should also specify which populations are intended or expected to be served or to have their needs addressed under the proposed project(s).

Culturally specific organizations are defined for the purposes of this solicitation as private nonprofit or Tribal organizations whose primary purpose as a whole is to provide culturally specific services to racial and ethnic groups, including, among others, Black people, Hispanic and Latino people, Native American and other Indigenous peoples of North America (including Alaska Native, Eskimo, and Aleut), Asian Americans, Native Hawaiians, and/or Pacific Islanders.

C. OJJDP will give priority consideration to applicants that demonstrate a commitment to ensuring fairness, equity, and access to justice for all children and families regardless of their race or ethnicity; religion; socioeconomic status; gender; age; mental health; cognitive, sensory, or physical disability; sexual orientation or gender identity or expression; geographic location; or other characteristics historically linked to discrimination or exclusion.

To receive this priority consideration, applicants must include in their application a plan that describes how the applicant will incorporate these values and priorities into their
