Overview

The [U.S. Department of Justice](#) (DOJ), [Office of Justice Programs](#) (OJP), [Office of Juvenile Justice and Delinquency Prevention](#) (OJJDP) seeks applications for funding under the fiscal year (FY) 2023 Center for Youth Justice Transformation (CYJT) Program. The purpose of this program is to strengthen state and territory-level compliance with the Formula Grants Program authorized under the Juvenile Justice and Delinquency Prevention (JJDP) Act, to develop and implement training and technical assistance that supports state, territorial, Tribal, and community-level juvenile justice system reform efforts; and design and implement an online education program for best practices in juvenile justice reform. This program furthers the DOJ's mission by promoting innovation and reform in the juvenile justice system.

This solicitation incorporates guidance provided in the [OJP Grant Application Resource Guide](#), which provides additional information for applicants to prepare and submit applications to OJP for funding. **If this solicitation expressly modifies any provision in the OJP Grant Application Resource Guide, the applicant is to follow the guidelines in this solicitation as to that provision.**

Eligible Applicants:

For profit organizations other than small businesses, Native American Tribal organizations (other than Federally recognized Tribal governments), Nonprofits having a 501(c)(3) status with the IRS, other than institutions of higher education, Nonprofits that do not have a 501(c)(3) status with the IRS, other than institutions of higher education, Private institutions of higher education, Public and State controlled institutions of higher education, Small businesses

Nonprofit organizations that hold money in offshore accounts for the purposes of avoiding paying the tax described in 26 U.S.C. 511(a) are not eligible to apply.

OJJDP will consider applications under which two or more entities would carry out the federal award; however, only one entity may be the applicant. Program Description

Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

[OJJDP's](#) guiding philosophy is to enhance the welfare of America's youth and broaden their opportunities for a better future. To bring these goals to fruition, OJJDP is leading efforts to transform the juvenile justice system into one that will [Treat Children as Children](#); [Serve Children at Home, With Their Families, in Their Communities](#); and [Open Up Opportunities for System-Involved Youth](#). OJJDP encourages all proposed applications that work with youth to highlight how the proposed program aligns with these priorities.

OJJDP envisions a juvenile justice system centered on the strengths, needs, and voices of youth and families. Young people and family members with lived experience are vital resources for understanding and reaching persons involved or at risk of involvement with youth-serving systems. OJJDP asks stakeholders to join us in sustainably integrating bold, transformative youth and family partnership strategies into our daily work. OJJDP believes in achieving positive outcomes for youth, families, and communities through meaningful engagement and active partnerships, ensuring they play a central role in collaboratively developing solutions.

Applicants must describe how their proposed project/program will integrate and sustain meaningful youth and family partnerships into their project plan and budget. Depending on the nature of an applicant's proposed project, youth and family partnership could consist of one or more of the following:

- Individual-level partnership in case planning and direct service delivery (before, during, and after contact with youth-serving systems).
- Agency-level partnership (e.g., in policy, practice, and program development, implementation, and evaluation; staffing; advisory bodies; budget development).
- System-level partnership (e.g., in strategic planning activities, system improvement initiatives, advocacy strategies, reform efforts).

With this solicitation, OJJDP seeks to fund a new Center for Youth Justice Transformation (CYJT) to strengthen state and territory-level compliance with the Formula Grants Program authorized under the Juvenile Justice and Delinquency Prevention (JJDP) Act; to develop and implement training and technical assistance that supports state, territorial, Tribal, and community-level juvenile justice system reform

efforts; and to design and implement an online education program for best practices in juvenile justice reform.

Specific Information

OJJDP is committed to assisting states, territories, Tribes, and localities with developing effective and equitable juvenile justice systems that create safer communities and empower youth to lead productive lives. One of the most effective ways this is done is through the agency's comprehensive training and technical assistance efforts.

This program will require the development and implementation of three related components of training and technical assistance:

- Training and technical assistance designed to strengthen state and territory-level compliance with the requirements of the Formula Grants Program authorized under the Juvenile Justice and Delinquency Prevention (JJDP) Act and implementation of Formula Grants Program approved state plans,
- Training and technical assistance that supports state, territorial, Tribal, and community-level juvenile justice system improvement and reform efforts; and
- An online Youth Justice Transformation Institute that provides on-demand learning opportunities regarding best practices in youth delinquency prevention, intervention and treatment.

The successful applicant will provide coordinated resources and training and technical assistance to assist states and communities in the planning, establishing, operating, coordinating, and evaluating of juvenile justice systems.

The successful applicant will be responsible for providing training and technical assistance, developing and disseminating resources, and implementing methods to assess training and technical assistance provided. The successful applicant will be required to work closely with OJJDP leadership and staff, as well as other OJJDP training and technical assistance providers to carry out this program.

OJJDP encourages applicants to present creative and innovative concepts on how they would implement the program. As a key competitive factor, applicants must identify how they will implement the identified tasks, describe how they will ensure the timely delivery of requested training and technical assistance, and determine the cost efficiencies they will achieve in the management and staffing of the program.

Goals, Objectives, and Deliverables

Goals

This program's overall goal is to strengthen the ability of states, territories, Tribes, and communities to effectively apply the elements of the Juvenile Justice and Delinquency Prevention (JJDP) Act in addressing youth at-risk and delinquent behavior. Key principles of the JJDP Act include:

- Building and implementing an effective system for monitoring compliance with the core requirements within the state or territory;
- Achieving and maintaining state or territory compliance with the core requirements of the Formula Grants Program;
- Maximizing the impact of State Advisory Groups (SAGs);
- Designing and implementing a continuum of youth services that range from delinquency prevention to intervention, treatment, placement and aftercare;
- Adopting evidence-based approaches to delinquency prevention, intervention, treatment, placement and aftercare;
- Addressing the needs of dual-system youth; and
- Sharing information across state and local systems.

Objectives

This goal will be accomplished through three objectives:

1. To design and provide a comprehensive program of training and technical assistance designed to strengthen state and territory-level compliance with the requirements of the Formula Grants Program authorized under the Juvenile Justice and Delinquency Prevention (JJDP) Act and implementation of Formula Grants Program approved state plans;
2. To respond to training and technical assistance requests that support state, territorial, Tribal, and community-level juvenile justice system improvement and reform efforts; and
3. To develop and implement an online Youth Justice Transformation Institute for youth serving and juvenile justice practitioners that provides on-demand learning opportunities regarding best practices in youth delinquency prevention, intervention and treatment.

Deliverables

A description of the primary deliverables related to each objective are listed below. Other deliverables will depend upon available resources and/or agency need.

Objective 1 Deliverables:

- Multi-level training and technical assistance designed for Designated State Agencies (DSAs), Juvenile Justice Specialists, Compliance Monitors, other staff

and State Advisory Groups (SAGs) regarding requirements of the JJDP Act which supports the achievement and/or maintenance of compliance with the core requirements of the Formula Grant program and the implementation of the approved state plans. This includes assistance in the development of state and territory 3-year plans, procedure and policy manuals and other required materials as well as the continued enhancement of already developed OJJDP curricula and materials. TTA will be provided through a variety of platforms, to include onsite sessions, webinars, curriculum, roundtables, meetings, and other mechanisms, with the goal of facilitating a community of practice among states and territories.

Objective 2 Deliverables:

- Targeted, evidence-informed training and technical assistance to state, territorial, Tribal and/or local governments to develop and/or implement programs, policies, and practices to improve the juvenile justice system. This TTA will be at the request of OJJDP, with a focus on jurisdictions needing specific support, such as a state or territory that is facing an emerging crisis in their juvenile justice system, or a state or territory that does not (yet) participate in the Formula Grants Program under Title II of the JJDP Act. While the majority of training and technical assistance activities under this program will be for Objective 1 purposes, OJJDP expects to periodically request TTA support for jurisdictions or states on a time-limited basis. The successful applicant will need to monitor the costs for TTA under Objective 2 separately from those under Objective 1.

Objective 3 Deliverables:

- Content for OJJDP's Online Youth Justice Transformation Institute for youth serving and juvenile justice practitioners. The Institute should utilize the most current technologies for online learning, and that content should encompass the full range best practices in youth delinquency prevention, intervention, treatment, placement and aftercare.

In addressing the deliverables, applicants should propose the topics, types, quantity, duration, audiences, timing, and means of delivery of the types of training; and identify trainers with relevant expertise. The applicant should also include plans for evaluating training sessions, to include measuring changes in participants' knowledge, attitude, and behavior.

OJJDP training and technical assistance awardee standards. OJJDP has developed the Core Performance Standards for Training, Technical Assistance, and Evaluation to promote among providers the consistency and quality of OJJDP-sponsored training and technical assistance and to advance common expectations of performance excellence. The standards present minimum expectations that providers must meet for effective practice in the planning, coordination, delivery, and evaluation of training. Award

recipients must coordinate with OJJDP's National Training and Technical Assistance Center (NTTAC) in the assessment and delivery of services to ensure the effective use of OJJDP grant funding.

Requirements related to coordination of activities will include, but are not limited to:

- **Coordination with OJJDP NTTAC.** OJJDP requires all training and technical assistance projects to coordinate their activities with OJJDP NTTAC by complying with all OJJDP/NTTAC protocols to ensure coordinated delivery of services among providers and the effective use of OJJDP grant funding. OJJDP reserves the right to modify these protocols at any time with reasonable notice to the grantee prior to project completion.
- **OJJDP-funded webinars.** The award recipient must comply with OJJDP's Webinar Guidelines, as described in the core performance standards. Minimally, OJJDP training and technical assistance providers will submit information to OJJDP NTTAC in advance of all events for the online calendar, use the approved OJJDP presentation template, and record events and provide the final files which are compliant with Section 508 of the Workforce Rehabilitation Act to OJJDP or OJJDP's representative. - **Training information sharing.** OJP will collect information from its program offices on OJP-funded training and technical assistance events. Award recipients must use OJJDP's standard electronic training request form, submit information to NTTAC on all training events (e.g., name of requestor, description of request, dates of event) 30 days in advance of the event date, and report additional data, as OJJDP requires.

1. Priority Considerations Supporting Executive Order 13985, *Advancing Racial Equity and Support for Underserved Communities Through the Federal Government*

In support of this [Executive Order](#), OJP will provide priority consideration when making award decisions to the following:

A. Applications that propose project(s) that are designed to promote racial equity and the removal of barriers to access and opportunity for communities that have been historically underserved, marginalized, and adversely affected by inequality.

To receive this consideration, the applicant must describe how the proposed project(s) will address potential racial inequities and contribute to greater access to services and opportunities for communities that have been historically underserved, marginalized, and adversely affected by inequality, and identify how the project design and implementation will specifically incorporate the input or participation of those communities and populations disproportionately impacted by crime, violence, and the criminal justice system overall. Examples addressing this requirement include, but are not limited to, the following: budgeted project planning and/or implementation meetings with community stakeholders representing historically underserved and marginalized communities; outreach and/or public awareness campaigns specifically tailored to historically underserved and marginalized communities to encourage participation in the proposed project(s); budgeted incorporation of members representing historically underserved and marginalized communities in program evaluation, surveys, or other means of project feedback; and partnership with organizations that primarily serve communities that have been historically underserved, marginalized, and adversely affected by inequality.

B. Applicants that demonstrate that their capabilities and competencies for implementing their proposed project(s) are enhanced because they (or at least one proposed subrecipient that will receive **at least 40%** of the requested award funding, as demonstrated in the Budget Web-Based Form) identify as a *culturally specific organization*.

To receive this additional priority consideration, applicants must describe how being a culturally specific organization (or funding the culturally specific subrecipient organization (s)) will enhance their ability to implement the proposed project(s) and should also specify which populations are intended or expected to be served or to have their needs addressed under the proposed project(s).

Culturally specific organizations are defined for the purposes of this solicitation as private nonprofit or Tribal organizations whose primary purpose as a whole is to provide culturally specific services to racial and ethnic groups, including, among others, Black people, Hispanic and Latino people, Native American and other Indigenous peoples of North America (including Alaska Native, Eskimo, and Aleut), Asian Americans, Native Hawaiians, and/or Pacific Islanders.

Note: Addressing these priority areas is one of many factors that OJP considers in making funding decisions. Receiving priority consideration for one or more priority areas does not guarantee an award.

Proposal Abstract

A Proposal Abstract (no more than 400 words) summarizing the proposed project — including its purpose, primary activities, expected outcomes, the service area, intended beneficiaries, and subrecipients (if known) — must be completed in the JustGrants web-based form. This abstract should be in paragraph form without bullets or tables, written in the third person, and exclude personally identifiable information. Abstracts will be made publicly available on the OJP and USASpending.gov websites if the project is awarded. See the [OJP Grant Application Resource Guide](#) for an example of a proposal abstract.

Proposal Narrative

The proposal narrative should be submitted as an attachment in JustGrants. The attached document should be double-spaced, using a standard 12-point font; have no less than 1-inch margins; and should not exceed 30 numbered pages. If the proposal narrative fails to comply with these length restrictions, OJJDP may consider such noncompliance in peer review and in final award decision. Tables, charts, and/or graphs included in the program narrative can be created in a legible font smaller than 12 point. Those items will count toward the page limit.

The proposal narrative must include the following sections:

a. Description of the Issue

Applicants should briefly describe the nature and scope of the need for training and technical assistance as outlined in the Goal and Objectives earlier in this solicitation. The applicant should use data to provide evidence that the need exists, demonstrate the size and scope of the problem, and document the effects of the problem on the target population and the larger community. Applicants should describe the target population and any previous or current attempts to implement a training and technical assistance program. Applicants should describe any research or evaluation studies that relate to the problem and

contribute to their understanding of its causes and potential solutions..

b. Project Design and Implementation

Applicants should detail the strategy to address the needs identified under the Description of the Issue. List the activities and describe how they relate to the stated goal and objectives. Activities include the specific actions to be undertaken to fulfill the program's objectives and reach the program's goal(s). Provide a detailed description of the method(s) to be used to carry out each activity. Provide a timetable indicating roughly when the activities or program milestones are to be accomplished. Applicants should detail how the project will operate throughout the funding period and describe the strategies that they will use to achieve the goals and objectives identified. Applicants should describe how they will complete the deliverables stated in the Goals, Objectives, and Deliverables section

Applicants should describe their vision and plan for meaningfully and sustainably integrating youth and family partnership into their proposed project. Applicants should address any corresponding budget implications in their application's budget detail and budget narrative. For resources/guidance on effective youth and family partnership strategies and practices, click [here](#).

If an applicant believes that their project design is in no way amenable to incorporating youth and family partnership, the applicant should instead provide a detailed explanation and justification for excluding this element.

If the applicant is seeking priority consideration for Priority 1(A), it should address in this section how the proposed project(s) will promote racial equity and the removal of barriers to access and opportunity for communities that have been historically underserved, marginalized, and adversely affected by inequality, and identify how the project design and implementation will specifically incorporate the input or participation of these communities.

c. Capabilities and Competencies

This section should describe the experience and capability of the applicant organization and any contractors or subgrantees that the applicant will use to implement and manage this effort and its associated federal funding, highlighting any previous experience implementing projects of similar design or magnitude. Applicants should highlight their experience/capability/capacity to manage subawards, including details on their system for fiscal accountability. Management and staffing patterns should be clearly connected to the project design described in the previous section. Applicants should describe the roles and responsibilities of project staff and explain the program's organizational structure and operations. Applicants should include a copy of an organizational chart showing how the organization operates, including who manages the finances; how the organization

manages subawards, if there are any; and the management of the project proposed for funding.

If the applicant is seeking priority consideration under Priority 1(B), it should describe within this section how being a culturally specific organization (or funding a culturally specific subrecipient organization at a minimum of 40% of the project budget) will enhance its ability to implement the proposed project(s), specify which populations are intended or expected to be served or have their needs addressed under the proposed project(s), and include the website address (if applicable) and formal or informal mission statement or principles of the culturally specific organization.

d. Plan for Collecting the Data Required for This Solicitation’s Performance Measures

Describe the process for measuring project performance. Identify who will collect the data, who is responsible for performance measurements, and how the information will be used to guide and evaluate the project’s impact. Describe the process to accurately report data.

- Correct validation errors, if necessary, and then return to the “Certify and Submit” screen to submit the application. Access the [Application Submission Validation Errors Quick Reference Guide](#) for step-by-step instructions to resolve errors prior to submission.
- Once the application is submitted and validated, a confirmation message will appear at the top of the page. Users will also receive a notification in the “bell” alerts confirming submission.
