OJJDP Court Appointed Special Advocates Grant Program Grid

The following pages outline the performance measures for the OJJDP Court Appointed Special Advocates (CASA) grant program and the data that the grantee must provide to calculate the performance measures. The OJJDP Performance Measures Tool (PMT) automatically performs the calculations on the grid with the values entered. Examples of calculated values include percentages, total amounts, and averages.

The grantee and/or its subrecipients are required to provide data for the indicators in the Data Grantee Reports column.

The performance measures for activities funded under the CASA grant program are reported in the OJJDP PMT semiannually.

The activities funded by the CASA grant program are organized into two program categories: Local CASA-funded projects and National CASA projects. The grantee is asked to select the program categories that correspond to the activities approved in the OJJDP application. The system then generates performance measures for each respective category. The grid that follows is divided into the two program categories and the corresponding measures for each.

After entering data in the PMT, the grantee is responsible for creating a *Performance Data Report* from the DCTAT in January and July of each calendar year. The grantee then submits this report to OJJDP through the Grants Management System (GMS).
