



Fiscal Year 2020 Strengthening Investigative Tools and Technology for Combating Child Sexual Exploitation Performance Measures

The following pages outline performance measures for the **Fiscal Year 2020 Strengthening Investigative Tools and Technology for Combating Child Sexual Exploitation** program and list the data that grantees must report on to complete a Performance Data Report. The Office of Juvenile Justice and Delinquency Prevention (OJJDP) requires grantees to provide data for the performance measure in the column labeled “Data Grantee Reports.” Grantees enter their data in a customized tool provided to grantees awarded funds under this program.

Grantees enter data in January and July of each calendar year and are responsible for creating their Performance Data Report. Grantees submit this report to OJJDP through the Grants Management System (GMS).

Percentage of users reporting satisfactory use of the application	Performance measure focuses on overall customer satisfaction with the application. Satisfaction with the application is defined as the application being acceptable or fulfilling expectations or needs. A user needs to use the application at least once during the activity period to be reported on for this measure. User surveys are the preferred data source. Number of users reporting improvement in their investigative practices	Performance measure focuses on the efficiency and effectiveness of the application. This measure demonstrates whether, after using the application, the application enhances the efficiency and effectiveness of the development, refinement, and advancement of investigative tools, methods, and technologies that address child pornography,	<ul style="list-style-type: none"> A. A user needs to use the application at least once during the activity period to be reported on for this measure. User surveys are the preferred data source. A user can be an individual, organization, or government agency.</p>		
<p>Percentage of users reporting a false positive</p>	<p>Performance measure focuses on the accuracy and quality of the application. A false positive is defined as the application delivering a positive result to identify a victim or offender, as described by the application guidelines and the developer, when the application should have delivered a negative result according to data validation and verification. Count a user as reporting a false positive result if the user receives a false positive result at least once or more during the activity period. The false positive result can be caused by human error, developer error, a change in technology, or other explanations. A user needs to use the application at least once during the activity period to be reported on for this measure. User surveys or</p>	<p>A. <p>Number of users reporting an increased ability to investigate crimes</p>	<p>Performance measure focuses on the impact of the application and its usefulness in overcoming technology-related investigative challenges. Increased ability to investigate a crime may include the identification of a criminal act, offender, or victim, and evidence supporting the above identification, that was previously not possible without the application. For example, the identification of perpetrators trading child pornography in virtual private networks. Using a survey conducted during the activity period, only count users that report an increased ability to investigate crimes when using the application. The survey should be conducted a minimum of 3–6 months after the user first employs the application. Only those who used the application at least once are surveyed. A user can be an individual, organization, or government agency.</p>	<p>A. Number of users reporting an increased ability to investigate crimes using the application B.
