Overview

The <u>U.S. Department of Justice</u> (DOJ), <u>Office of Justice Programs</u> (OJP), <u>Office of Juvenile Justice and Delinquency Prevention</u> (OJJDP) seeks applications for funding to close and repurpose youth detention and correctional facilities, reinvest cost savings to expand community-based alternatives to incarceration, and assess and respond to the economic impact of closures on facility staff and surrounding communities. This program furthers the DOJ's mission to reduce recidivism and improve public safety by helping jurisdictions more effectively and equitably reinvest resources in efforts that facilitate the successful reintegration of justice-involved youth.

This solicitation incorporates guidance provided in the OJP Grant Application Resource Guide, which provides additional information for applicants to prepare and submit applications to OJP for funding. Program Description

Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

OJJDP's guiding philosophy is to enhance the welfare of America's youth and broaden their opportunities for a better future. To bring these goals to fruition, OJJDP is leading efforts to transform the juvenile justice system into one that will Treat Children as Children; Serve Children at Home, With Their Families, in their Communities; and Opportunities for System-Involved Youth. OJJDP encourages all proposed applications that work with youth to highlight how the proposed program aligns with these priorities.

OJJDP envisions a juvenile justice system centered on the strengths, needs, and voices of youth and families. Young people and family members with lived experience are vital resources for understanding and reaching persons involved or at risk of involvement with youth-serving systems. OJJDP asks stakeholders to join us in sustainably integrating bold, transformative youth and family partnership strategies into our daily work. OJJDP believes in achieving positive outcomes for youth, families, and communities through meaningful partnership and active partnerships, ensuring they play a central role in collaboratively developing solutions.

Applicants must describe how their proposed project/program will integrate and sustain meaningful youth and family partnerships into their project plan and budget. Depending on the nature of an applicant's proposed project, youth and family partnership could consist of one or more of the following:

- Individual-level partnership in case planning and direct service delivery (before, during, and after contact with youth-serving systems).
- Agency-level partnership (e.g., in policy, practice, and program development, implementation, and evaluation; staffing; advisory bodies; budget development).
- System-level partnership (e.g., in strategic planning activities, system improvement initiatives, advocacy strategies, reform efforts).

With this solicitation, OJJDP seeks to fund jurisdictions to close and repurpose youth detention and correctional facilities, reinvest cost savings to expand community-based alternatives to youth incarceration, and assess and respond to the economic impact of closures on facility staff and surrounding communities.

Statutory Authority

Department of Justice Appropriations Act, 2023, Pub. L. No. 117-328, 136 Stat. 4459, 4537.

Specific Information

The Community-Based Alternatives to Youth Incarceration Initiative will support jurisdictions to close youth detention and correctional facilities, assess and respond to the impact of closures on facility staff and the surrounding communities, and reinvest state and local resources to support more effective community-based services and supports for justice-involved youth and their families. This is an opportunity for states, Tribal governments and localities to innovate and explore spending alternatives to develop, expand, and enhance community-based alternatives to youth incarceration and address public safety priorities. The initiative will support the development and implementation of innovative strategies for closing youth detention and correctional facilities and reinvesting cost savings in community-based solutions that promote positive outcomes for youth, increase public safety, and strengthen neighborhoods.

Funding will support jurisdictions in a community-driven consultation and justice reinvestment planning process that leverages the expertise of staff, representatives from impacted communities, community-based service providers, local foundations, and other key stakeholders to help close and repurpose youth detention and correctional facilities. Stakeholders may include representatives from the state judiciary (chief justice, family court judges, other judges); legislature (Senate leader, judiciary chairs, Speaker of the House, appropriations committee, other legislators); and the executive (Governor, budget officials, city government, including the mayor).[1] Other relevant stakeholders include youth and families, advocacy groups, social services agencies, and public health.

The initiative will be supported by a training and technical assistance provider to assist grantees in the planning process as needed, identify evidence-informed practices for correctional and detention facility closure, and develop economic impact strategies that result in cost savings and reinvestment in community-based alternatives to youth incarceration.

[1] In general, as a matter of federal law, federal funds awarded by OJP may not be used by the recipient, or any subrecipient ("subgrantee") at any tier, either directly or indirectly, to support or oppose the enactment, repeal, modification, or adoption of any law, regulation, or policy, at any level of government. See 18 U.S.C. 1913. (There may be exceptions if an applicable federal statute specifically authorizes certain activities that otherwise would be barred by law.)

Another federal law generally prohibits federal funds awarded by OJP from being used by the recipient, or any subrecipient at any tier, to pay any person to influence (or attempt to influence) a federal agency, a Member of Congress, or Congress (or an official or employee of any of them) with respect to the awarding of a federal grant or cooperative agreement, subgrant, contract, subcontract, or loan, or with respect to actions such as renewing, extending, or modifying any such award. Goals, Objectives, and Deliverables

Goals

The goals of this initiative are to assist jurisdictions in closing and repurposing youth detention and correctional facilities, assess and respond to the economic impact of closures on facility staff and the surrounding communities, and reinvest cost savings in expanding

community-based alternatives to youth incarceration.

Objective

The objective of this initiative is to support jurisdictions in developing and implementing community-driven plans to close and repurpose youth detention and correctional facilities. Applicants are expected to engage, and leverage expertise from, stakeholders, community-based service providers, local foundations, and members of the impacted communities in a strategic planning process. Plans must respond to the economic impact of closures on facility staff and the surrounding communities, as well as sustainable, data-driven strategies to reinvest cost savings from youth detention and correctional facility closures into proven, effective youth justice programs and services.

Deliverables

Category 1: Community-Based Alternatives to Youth Incarceration: Planning and Feasibility Assessments

Jurisdictions funded under Category 1 are expected to conduct a feasibility assessment to develop a community-driven strategic plan to support the initiative's goals and objectives.

Selected applicants will engage in the following planning activities:

- Identify existing alternatives to youth detention and incarceration and review the
 capacity and effectiveness of these alternatives in the jurisdictions of focus. From this
 review, co-design, improve, and expand the continuum of community-based services
 to address the needs of impacted youth.
- · Develop a plan for the feasibility assessment.
- Develop a process for convening a diverse committee of critical stakeholders, including state- and local-level decisionmakers, juvenile justice agency leaders (including juvenile probation, detention, and corrections), state labor agency representatives, youth- and family-serving community-based service providers, impacted youth and their families, and community leaders and advocates.
- Work collaboratively with the OJJDP-approved training and technical assistance provider to conduct the feasibility assessment and develop the strategic plan.

Category 2: Community-Based Alternatives to Youth Incarceration Initiative: Implementation

Jurisdictions funded under Category 2 are expected to develop community-driven, strategic plans to achieve the initiative's goals and objectives.

Selected applicants will engage in the following planning activities:

- Convene and collaborate with a diverse committee of critical stakeholders, including state- and local-level decisionmakers, juvenile justice agency leaders (including juvenile probation, detention, and corrections), state labor agency representatives, youth- and family-serving community-based service providers, impacted youth and their families, and community leaders and advocates.
- · Conduct data analysis, including surveys and interviews, with youth and community

- stakeholders impacted by the closure of detention and correctional facilities, as well as the staff who currently work in the youth detention and correctional facilities.
- Conduct a fiscal analysis of current and projected resources and expenditures. This
 would involve assessing how the jurisdiction's youth detention system currently
 spends its funding, including (1) identifying sources of funding, (2) the amount that the
 system spends on each type of intervention, (3) trends in the total costs for each
 intervention category, (4) the cost per unit of capacity (e.g., annualized cost per
 available bed), and (5) costs per young person.
- Review the capacity and effectiveness of existing alternatives to youth incarceration in the impacted communities. From this review, co-design, improve, and expand the continuum of community-based services to address the needs of impacted youth.
- Develop a short-, intermediate-, and long-term strategic plan, with assistance from an OJJDP-approved training and technical assistance provider, for closing and repurposing the youth detention or correctional facility; redirecting resources from the facility closure into proven, effective youth justice programs and services; and responding to the economic impact of the closure on facility staff and the surrounding communities. This plan should include:
 - Cost estimates and sources of funding.
 - Timeline for implementation.
 - Strategies to train and redeploy staff currently employed by the youth detention facility.
 - In jurisdictions where the plan is to repurpose/maintain use of the facility, the plan should include community engagement and co-design efforts to ensure resources are meeting the needs of the impacted youth and community.
- Work collaboratively and closely with the OJJDP-approved training and technical assistance provider.

Successful examples of repurposing a closed youth detention facility to improve public safety and strengthen neighborhoods include, but are not limited to, using the space for:

- A "teen center" that offers communal space, free Internet, a music room, and other entertainment for youth.
- A recovery center and "one-stop shop" for social services.
- A reentry center for justice-involved youth and adults.
- Other purposes such as affordable housing, commercial space, public parks, or event space.

The Goals, Objectives, and Deliverables are directly related to the performance measures that show the completed work's results, as discussed in the "Application and Submission Information" section.

1. Priority Considerations Supporting Executive Order 13985, Advancing Racial Equity and Support for Underserved Communities Through the Federal Government

In support of this Executive Order, OJP will provide priority consideration when making award decisions to the following:

A. Applications that propose project(s) that are designed to promote racial equity and the removal of barriers to access and opportunity for communities that have been historically underserved, marginalized, and adversely affected by inequality.

To receive this consideration, the applicant must describe how the proposed project(s) will address potential racial inequities and contribute to greater access to services and opportunities for communities that have been historically underserved, marginalized, and adversely affected by inequality, and identify how the project design and implementation will specifically incorporate the input or participation of those communities and populations disproportionately impacted by crime, violence, and the criminal justice system overall. Examples addressing this requirement include, but are not limited to, the following: budgeted project planning and/or implementation meetings with community stakeholders representing historically underserved and marginalized communities; outreach and/or public awareness campaigns specifically tailored to historically underserved and marginalized communities to encourage participation in the proposed project(s); budgeted incorporation of members representing historically underserved and marginalized communities in program evaluation, surveys, or other means of project feedback; and partnership with organizations that primarily serve communities that have been historically underserved, marginalized, and adversely affected by inequality.

B. Applicants that demonstrate that their capabilities and competencies for implementing their proposed project(s) are enhanced because they (or at least one proposed subrecipient that will receive at least 40% of the requested award funding, as demonstrated in the Budget Web-Based Form) identify as a *culturally specific organization*.

To receive this additional priority consideration, applicants must describe how being a culturally specific organization (or funding the culturally specific subrecipient organization(s)) will enhance their ability to implement the proposed project(s) and should also specify which populations are intended or expected to be served or to have their needs addressed under

Culturally specific organizations are defined for the purposes of this solicitation as private nonprofit or Tribal organizations whose primary purpose as a whole is to provide culturally specific services to racial and ethnic groups, including, among others, Black people, Hispanic and Latino people, Native American and other Indigenous peoples of North America (including Alaska Native, Eskimo, and Aleut), Asian Americans, Native Hawaiians, and/or Pacific Islanders.

C. OJJDP will give priority consideration to applicants that demonstrate a commitment to ensuring fairness, equity, and access to justice for all children and families regardless of their race or ethnicity; religion; socioeconomic status; gender; age; mental health; cognitive, sensory, or physical disability; sexual orientation or gender identity or expression; geographic location; or other characteristics historically linked to discrimination or exclusion.

To receive this priority consideration, applicants must include in their application a plan that describes how the applicant will incorporate these values and priorities into their program design.

Note: Addressing these priority areas is one of many factors that OJP considers in making funding decisions. Receiving priority consideration for one or more priority areas does not guarantee an award.

This abstract should be in paragraph form without bullets or tables, written in the third person, and exclude personally identifiable information. Abstracts will be made publicly available on the OJP and USASpending.gov websites if the project is awarded. See the OJP Grant Application Resource Guide for an example of a proposal abstract.

Proposal Narrative

The proposal narrative should be submitted as an attachment in JustGrants. The proposal narrative must include the following sections:

a. Description of the Issue

Any data or research referenced in the narrative should include information about the source of the data and/or a citation. Applicants should describe the target population and any previous or current attempts to address the problem. Applicants should describe any research or evaluation studies that relate to the problem and contribute to their understanding of its causes and potential solutions. While OJJDP expects applicants to review the research literature for relevant studies, they should also explore whether unpublished local sources of research or evaluation data are available.

b. Project Design and Implementation

Applicants should detail how the project will operate throughout the funding period and describe the strategies that they will use to achieve the goals and objectives identified in the previous section. Applicants should describe how they will complete the deliverables stated in the Goals, Objectives, and Deliverables section. If the applicant is seeking priority consideration for Priority 1(C), it should address in this section how the proposed project(s) will ensure fairness, equity, and access to justice for all children and families regardless of their religion; gender; age; mental health; cognitive, sensory, or physical disability; sexual orientation or gender identity;

or other characteristics historically linked to discrimination or exclusion not already identified under Priority 1(A).

c. Capabilities and Competencies

This section should describe the experience and capability of the applicant organization and any contractors or subgrantees that the applicant will use to implement and manage this effort and its associated federal funding, highlighting any previous experience implementing projects of similar design or magnitude. Applicants should highlight their experience/capability/capacity to manage subawards, including details on their system for fiscal accountability. Management and staffing patterns should be clearly connected to the project design described in the previous section. Applicants should describe the roles and responsibilities of project staff and explain the program's organizational structure and operations. Applicants should include a copy of an organizational chart showing how the organization operates, including who manages the finances; how the organization manages subawards, if there are any; and the management of the project proposed for funding.

If the applicant is seeking priority consideration under Priority 1(B), it should describe within this section how being a culturally specific organization (or funding a culturally specific subrecipient organization at a minimum of 40% of the project budget) will enhance its ability to implement the proposed project(s), should also specify which populations are intended or expected to be served or have their needs addressed under the proposed project(s), and should include the website address (if applicable) and formal or informal mission statement or principles of the culturally specific organization.

d. Plan for Collecting the Data Required for this Solicitation's Performance Measures
